All tuition payments are due on the 1st of each month. A late charge will be assessed to those accounts not current. Your child may be dismissed if your account is more than 2 weeks in arrears.
2. All extended care charges for the month are due and payable on the first of each month. Your child may be dismissed from the program if the account is more than 2 weeks in arrears.
3. A \$40.00 charge will be assessed for returned checks.
